Course Description and Objectives: This course aims to deepen the understanding of the major theories of personality on the one hand and psychopathology on the other hand.

Class Format: Lectures/Seminars led by the instructor and students.

Presentation 1: Two Students will collaborate on teaching one chapter/personality theory presented in the text book. Please remember to prepare a good summary that the class can use for studying for the exam. Email me your summary and I will post it on Moodle. Presentation length: as long as you need to make sure that the class acquires the necessary knowledge and understanding.

Presentation 2: Each student will be required to select a well-known individual who meets diagnostic criteria for a personality and/or a behaviour/mood disorder. Based on a reading of a biography or autobiography of that person, students will be expected to analyze this person in terms of his or her personality and development. Students will be expected to provide a diagnosis and to defend the diagnosis, by referring to two (or more) of the personality theorists covered in the first semester. Presentation length: No more than 30-45 minutes in length.

Winter Term Paper: An Elaboration of the same topic as the seminar presentation to be written in 2000 to 3000 words (approximately 10 pages). The essay should be typed, double-spaced, and written in accordance with the Publication Manual of the American Psychological Association APA style. You can go to http://www.apastyle.org/learn/tutorials/basics-tutorial.aspx for online tutorial. There will be a penalty of 5% (half letter grade) for each day late. Due date: Two weeks after each seminar presentation.
