Course Description

The purpose of this course is to introduce you to social psychological research and theory. I will discuss topics such as history and research methods in social psychology, attitudes, persuasion, altruism, and interpersonal relationships. I hope you will find the topics intellectually interesting and informative for understanding yourself and the world around you.

Description of Tests

You will be given three tests in this course. The tests are not cumulative: you will only be responsible for the materials covered since the last test. Test 3 will take place during the final exam period. The tests will be composed of multiple choices, true-false, and short answers.

Description of Assignment

The purpose of this assignment is to expand your knowledge of the concepts taught in the course, and apply them to our day to day lives. I would like you to choose a current event (something going on in the world, not an article about research) that took place between September 13, 2016, and the due date of this assignment. I would then like you to discuss this event in light of one or more concepts from the course. For example, you could choose a newspaper article about a person who collapsed in public and no one helped him, and then explain the newspaper article in terms of the bystander effect. More information about this assignment will be available later in the term. Your paper should be 3-5 pages long, double-spaced with 12-point font and one-inch margins. Your will be graded on:

- 1) The choice of appropriate concept(s) from the course
- 2) Correct and clear explanation of the concept(s)
- 3) Application of the concept(s) to the chosen event
- 4) The clarity of writing

The assignment is due on December 5, 2016. Late assignments will have a penalty of 5% per day.

You will be asked to complete short tasks after some of the online lectures. Completion of these tasks are required within one week of the delivered lecture online. Please listen to the lectures for more details.
