Course Description

An introduction to theory, methods, and research findings in the field of cognitive psychology. The goal of this course is to provide you with a thorough survey of the field of cognition, including the history of the field, cognitive neuroscience, attention, perception, memory, concept learning, language, reasoning, problem solving, and consciousness. Students will be exposed to laboratory demonstrations and experiments.

- 1. Demonstrate broad knowledge of cognitive psychology.
- 2. Describe and evaluate current theory and research in cognitive psychology.
- 3. Understand and interpret principles of cognition in everyday life.
- 4. Define causes of human cognition from different perspectives.

Description of Assignments

a) In-Class Exams: Exams will be non-cumulative and cover the material from lectures and readings. Any content from assigned chapters in textbook can be on exam. The format of the exams will be a mix of multiple-choice and short-answer questions.

b) Final Exam: The final exam will be non-cumulative and cover the material from lectures and readings. Any content from assigned chapters in textbook can be on exam. The format will be the same as the in-class exams (multiple choice and short-answer questions).

c) Assignment: There will be one assignment in this course. The assignment will involve commenting on research in cognitive psychology. Details regarding this assignment will be discussed in class. The assignment will be posted on March 15, 2019 and will be due on March 29, 2019. This due date is non-negotiable. You will be asked to submit your assignment to moodle and to turnitin by the specified date. Late assignments will be deducted 5% per day.

Grading as per Senate Policy
