**Group Presentations (20%):** You CAN use Prezi, Microsoft PowerPoint or a similar presentation-software as part of your presentation. Each group will present a one-hour presentation on their chosen topic. Be sure to speak clearly and present the information in an organized and coherent way (HINT: choose your best speakers). Do NOT simply read off your slides. Use them as a foundation for insightful discussion. Do NOT bore the class. Try to teach new things that have not yet been covered in class. Use books and scholarly journal articles ONLY. Keep non peer-reviewed information (i.e. Internet websites) to a minimum. Make sure work is divided evenly amongst group members – those who fail to contribute to their group's efforts will be required to submit a paper on their group's chosen topic (15-20 pages, following current APA format).

ALL group members MUST attend their own presentation. Each group will be required to provide the rest of the class with a 2-page (double-sided, single spaced) handout that contains a glossary of important terms and theories, a list of important articles and/or book chapters.

You may use a variety of media to enhance your presentation, including CDs, DVDs, films, YouTube, posters, photos, graphics etc. If you will be showing material of a graphic nature, please check with Dr. Luther before including it into your presentation, and include a disclaimer for the class prior to presenting said material. If unsure, ASK!!!

In order to fit all presentations into the allocated class time, the class MAY be divided into two smaller seminar groups (from 8:30pm to 9:50pm). Good luck!

**Goals:**

- To raise awareness of environmental influences on our emotions, behaviour, brain composition and spirit
- To learn about the impact of the environment on human populations both historically and currently
- To explore degradation of the planet's environment and atmosphere
- To learn about Charles Darwin's profound contribution to psychology
- To dissect the interaction of traits & place
- To appreciate the diversity of our natural life forms, including humans.
- To study human 'tribal' traits such as 'inherited' haplotypes and diseases
- To see the effects of diverse environment
- To learn about our positive and negative 'natures' (in situ)
- To see how personality evolves in humans
- To study the "Angels of our Better Nature" and the "Blonde Beast" in us, even now
- To examine our "good" and "bad" selves
